

## A Network of Support

---

In 2024 alone, the charity has funded projects and facilities that boost morale for those currently serving, helping 1109 beneficiaries and 40 dependents. This includes assistance with welfare and family life, as well as teambuilding activities, prizes and awards.

In the rare and tragic case of a Death in Service, the charity provides an immediate £20,000 payment to the next of kin, helping ease the burden during the most difficult times.

Through our grant-making, we've awarded over £80 000 in direct support to the RFA community.

We work closely with partner charities to ensure RFA children, families, and veterans are cared for and connected to the support they need.

## Relationships & Family Life

---

Life in the RFA brings unique pressures that can impact families and relationships. That's why we've partnered with Family Action, for any family in need and anyone without family support. Their services are freely available to all serving personnel, veterans, and their dependents.

Since 2020, RNRMC has invested nearly £300,000 in support for carers across the RFA, Royal Navy and Royal Marines communities ensuring carers of all ages can access resources and emotional support.



We also offer help for those in the neurodiverse community. Our Neurodiversity Navigator provides tailored guidance for families caring for neurodiverse children or young people, as well as for neurodiverse personnel themselves. This programme is supported in partnership with the Armed Forces Covenant Fund Trust (AFCFT).

## Wellbeing and Morale

---

Royal Navy & Royal Marines Charity is here, offering a steady presence and the reassurance that no one faces this journey alone. RNRMC fund initiatives that boost morale, build resilience, and promote a sense of connection — especially during deployments.



This includes pre-deployment days, family events, and support via organisations like Aggie Weston's, ensuring families feel prepared, informed, and supported while loved ones are at sea.




