Fit for Life

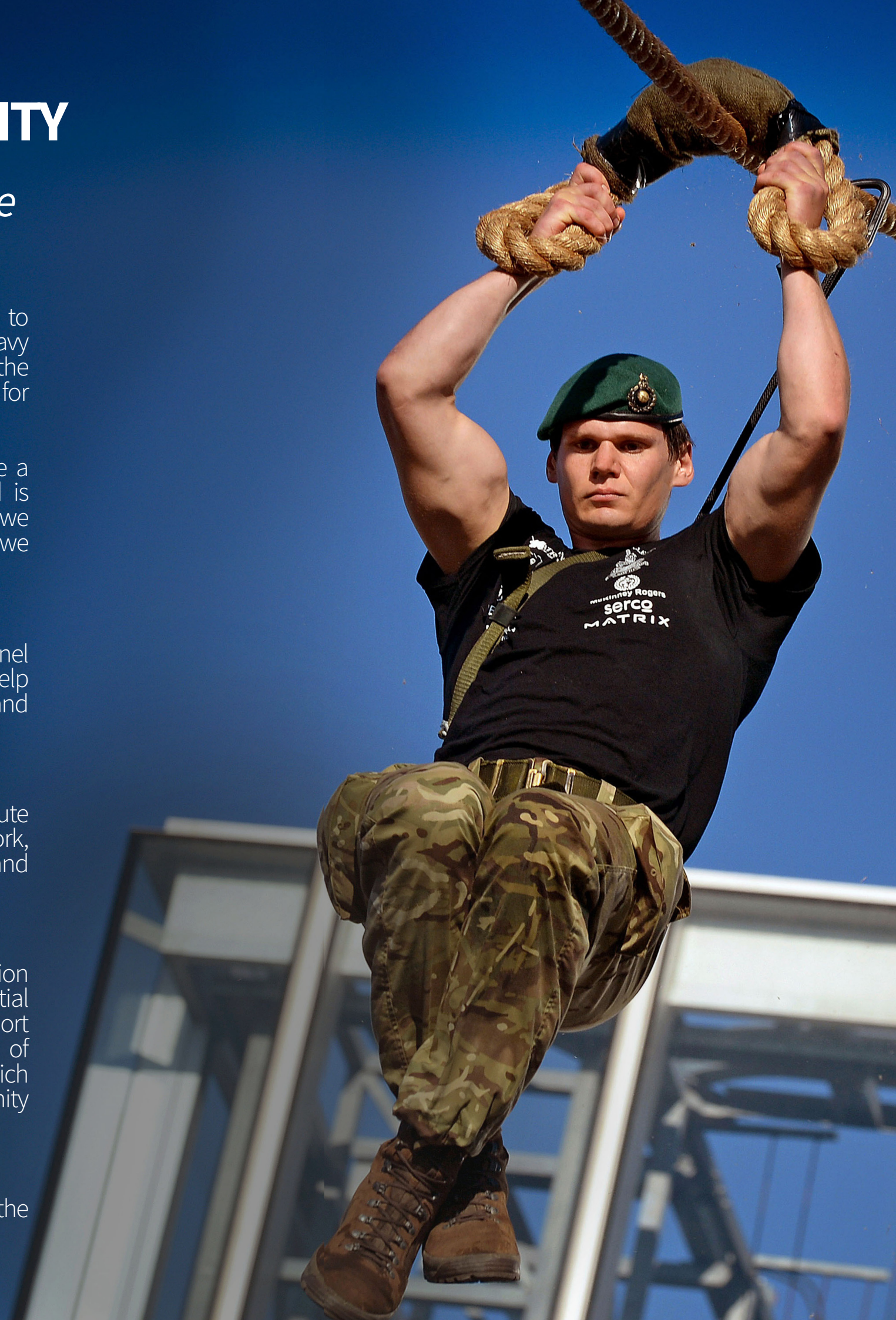
We aim to promote health and wellbeing and contribute to the naval ethos by enabling fitness and teamwork, helping boost efficiency and morale through sport and adventure training.
